- Schedule of Document Verification is available on Northern Railway's website <u>www.rrcnr.org</u> and will also be mentioned in the call letter. This will be conducted in the Divisional offices of Northern Railway.
- Call Letters for document verification are being sent by Post.
- Duplicate Call Letters can also be obtained from the office of RRC, Northern Railway, Lajpat Nagar-I, New Delhi-110 024 from 10.00 AM to 17.00 PM from 01.09.2012 onwards.
- Persons with Disabilities are exempted from PET.

Note:

- All necessary care has been taken while preparing the list for eligible candidates for document verification but inadvertent human errors cannot be overruled. RRC/Northern Railway reserves the right to correct such mistakes whenever it is noticed.
- Additional candidates are being called for the verification of document in excess of the existing vacancies under the PH Quota to avoid shortfall in the panel.
- It is clearly stated that this result is being published in order to adhere to the time schedule as per Hon'ble court's directions. Merit position as well as seniority of these candidates will be determined on the basis of position in the final panel as and when it is issued.
