Instructions to provisionally eligible candidates for selection trials for recruitment against Sports Quota (Open Advertisement) for the year 2021-22.

1.	Candidates must bring their playing kits and other sports equipment on the specified date at the specified venue and time.
2.	Candidates must bring originals of all certificates in support of their claims pertaining to age, educational qualifications including sports qualification, mark sheets, community and other claims by the candidates.
A	Eligible / Provisionally Eligible Candidates are advised to be in readiness to appear for Document verification / Trial as per schedule attached along with the following documents in original and 2 sets of self-attested photocopies: -
B	Application form downloaded from website.
C	Date of Birth proof Certificate (Standard 10th or its equivalent Certificate or Mark sheet indicating Date of Birth or school leaving certificate indicating Date of Birth.
D	Educational Qualification Certificates
E	Sports Achievement Certificates
F	Caste certificate in Central Govt. format (for SC/ST/OBC where ever applicable)
G	Aadhaar card
H	Two recent passport size photographs
I	Valid photo ID
J	Minority Community Declaration Affidavit (where ever applicable)
K	EBC certificate (where ever applicable)
L	NOC from the employer if already working
3	Candidates must bring one set of self-attested photocopies of all certificates. They must also bring at least one photo ID proof viz. Voter ID, Aadhar Card, PAN Card, Passport, Driving License, etc. Four stamp size photographs, identical to the one submitted with application form, must be brought as well.
4	All certificates must be in prescribed format as per the notification.
5	No request, whatsoever, shall be entertained in any circumstances for change of date, time and venue for the selection trials.
6	RRC/NR reserves the right to change the time, date and venue of the selection trials.
7	Special instruction in view of COVID-19 pandemic:
(a)	All candidates must wear a face mask (without valve) and carry hand sanitizer.
(b)	Candidates must adhere to social distancing norms and maintain personal hygiene at all time.
8.	Candidates must follow all instructions mentioned in the sports quota notification and the call letter.
